# Minutes of the Board of Trustees Meeting June 28, 2022

The Board of Trustees of the Cape Girardeau County Public Health Center met at Shawnee Park Center, 835 South West End Blvd., Cape Girardeau, Missouri on Tuesday, June 28, 2022 at 3:30 p.m. Present were, Chair John Freeze, Vice Chair Georganne Syler, Secretary-Treasurer Billy Lewis, Eric Becking, Diane Howard, Director Jane Wernsman, Assistant Director Autumn Grim, and Environmental Health Supervisor Amy Morris. The agenda was distributed via email prior to the meeting.
